

# REPUBLIC OF ANGOLA EMPRESA PORTUÁRIA DO LOBITO, E.P PUBLIC TENDER NOTICE No. 01 /2021

Empresa Portuária do Lobito, E.P., hereby announces that, pursuant to the provisions of Article 69(1) and Annex VI, Law No 9/16, of 16<sup>th</sup> June - the Public Procurement Law -, the Public Tender is open for the concession of the public service for the management and operation of the Container and General Cargo Multipurpose Terminal of the *Porto Comercial do Lobito* (Lobito Commercial Port).

### 1. Data of the Contracting Public Entity (EPL):

- 1.7. Type of contracting entity and its main activities:

EPL is a public company, a legal person with administrative, financial and patrimonial autonomy. Its main attributions are the powers of administration, management and authority in sea and land areas under its jurisdiction; the promotion, planning and regulation of the *Porto Comercial do Lobito*; the coordination and supervision of activities in its area of jurisdiction, promoting the construction works, organising the services and setting fees and tariffs, policies and general rules, with a view to the economic operation of the port and the proper use of public domain property, safeguarding the sea and land environment.

1.8. EPL is hiring on its own account.

#### 2. Information about the contract:

- 2.1. Name given to the contract by EPL: Contract for Concession of the Public Service for the Management and Operation of the Container and General Cargo Multipurpose Terminal of the *Porto Comercial do Lobito*.
- 2. 2. Type of contract: Public Service Concession
- 2.3. Location where the services will be provided: Container and General Cargo Multipurpose Terminal, *Porto Comercial do Lobito*, Benguela Angola
- 2.4. The invitation to tender is open to foreign entities.
- 2.5. The contracting process shall culminate in the signing of a public service concession contract.
- 2.6. Brief description of the services that are the object of the contract:

- a) Management and operation of the Multipurpose Container and General Cargo Terminal at the *Porto Comercial do Lobito*, in the form of Landlord Port management;
- b) Drawing up the terminal's Operation and Organisation Plans containing the operational organisation of the concession area, as well as the rules regarding environmental, hygiene and safety requirements;
- c) Construction, repair and preservation of the establishment allocated to the concession;
- d) Installation and/or replacement of the equipment necessary for the performance of the contract;
- e) Guarantee of the economic viability of the Terminal, in compliance with the norms of the contract and with the procedural documents.
- 2.7. Deadline for implementation of the contract: 20 years.

## 3. Information about the tenderers and the proposals:

- 3.1. The tenderers must meet the following conditions, cumulatively:
  - a) To present a paid-up equity capital of no less than the equivalent to USD 25 million (Twenty-five Million US Dollars).
  - **b)** To present an average annual turnover of the last 3 financial years of not less than the equivalent of USD 100 million (One Hundred Million US Dollars).
  - c) To have net assets of not less than the equivalent of USD 100 million (One Hundred Million US Dollars).
  - d) Technical capacity The bidding companies should have, directly or through subsidiaries, a participation of no less than 25% in at least 3 port terminal concession operations in the last 3 years, and, in at least one of those operations, have a participation of no less than 50%, with an average annual throughput during the last 3 years of no less than 250.000 TEUs (Two Hundred and Fifty Thousand TEUs).
  - e) In the case of an association of companies, the criterion mentioned in the lines above must be fulfilled by one of the elements having a minimum 25% shareholding in such an association.
- 3.2. Varying offers are not admissible.
- 3.3. Provisional surety is not required.

### 4. Award criterion

The award criterion is that of the most advantageous proposal for EPL, taking into account the factors set out in the procedural documents.

- 5.4.1. Tenderers shall submit their proposals in physical form (paper), in the *Concessões* room, located inside the building: *Terminal de Contentores do Porto do Lobito, 1st floor, Rua 1 de Dezembro,* Lobito Municipality, Benguela, in two closed and sealed opaque envelopes, addressed to *A COMISSÃO DE AVALIAÇÃO DAS CONCESSÕES* (THE CONCESSION EVALUATION COMMISSION), on the cover of which should be written "*Proposta*" (Proposal), with the title "*Documentação Geral*" (General Documents) on the first, and the title "*Proposta Técnico-Financeira*" (Technical-Financial Proposal) on the second. Both must mention the name of the proposal and the company name of the tenderer and must be signed by the person representing it.
- 5.4.2. It is mandatory to submit a duplicate of each of the documents constituting the bid, and, together with the said documents, also a *flash drive / memory stick* containing all the elements of the proposal.
- 5.5. Proposals submitted after the deadline shall not be considered.
- 5.6. All proposals will be opened in Public Act, to be held on 17<sup>th</sup> August 2021, at 9:00 am, at the EPL headquarters.
